

Factory-built house that looks 'like shipping container' gets go-ahead

BIRMINGHAM'S first factory-built

council home has been given the green light, despite it being branded "a shipping container".

A crane will drop the two-storey, two-bedroom unit into a vacant plot of land on Heaton Street. Hockley, after Birntingham City Council's planning committee approved it.

But some have called for the appearance to be changed first,

"Ihere is no way on earth I would inflict that sort of property on an area within the city I live," said councillor Bob Beauchamp.

"It's absolutely not the best that can be done with modular building. I have never seen anything so ugly and primitive in all my life."

The concerns were echoed by Cile Adam Higgs, who described it
